## Old/New Business

- Drainage Richard will look into the drainage issues in two areas. The drain next to 6942 Red Sand Grove and the other is in the courtyard grass area.
- Concrete Daryn has everything ready to do the concrete repair and is just waiting on the weather to improve.
- Reserve Study Kristie received 3 bids and the Board voted to go with Association Reserve's 8 week bid. Pulte will reimburse the association for the cost. Pulte will also pay for a transition \ up dated study at turn over.
- Richard is requesting the fire department remove fire lane signs where the original site map called for street parking.
- Tom has signed and mailed the 2007 tax return.
- The Board approved getting a website at a cost of \$585.00 for the first year and \$200.00 per year after that.
- ELM has not replaced the missing or dead plants from last year's request. ValleyCrest or who ever the contract goes to will be ask to give a bid and replace the plants. Pulte will reimburse the HOA for the cost incurred.
- John Deere filed liens on a handful of homeowners' due to non-payment from ELM. Richard found that John Deere has been paid in full and that John Deere is in the process of removing the liens.
- There has been a problem with homeowners not picking up after their dogs in the common areas. Tom is going to write an article for the newsletter. Kristie will call The Scoop for a one time clean up. Kristie will check into having a license program for the dogs.
- Fire access gate for a possible day care on the corner of Shimmering Creek and Dublin. The Board approved to allow them to put in a gate with the details to be worked out with the day care.

• ValleyCrest has not been following the requirements of the contract. Kristie will get 3 bids for landscapers. Pulte Homes is going to have a meeting with ValleyCrest to use their larger influence to try to get them to perform at a higher level.
